\*It is important to note various mandatory government movement control orders (MCOs) are in place to prevent the spread of COVID-19, a despite all prior issues being closed, restriction of movement remains factually present.

Working closely with various stakeholders, the company was cleared by US Customs and Border Protection (CBP) and allowed to resume exporting and selling gloves manufactured by its Malaysian factories to the US following the modification (lifting) of the finding by the CBP effective Sept 10.
